Dear Member - Your Hamilton Membership is due for renewal on 1st April 2018.

This year, the Junior Membership form is separate and also acts as the Parental Consent Form.

Payment for Membership Renewal can be made by –

- Cash
- Cheque (made payable to HLTC)
- Credit or Debit Card
- Standing Order (Full Tennis & Tennis Family Memberships only)
- Advantage Card points already accrued
- A combination of Advantage Card points accrued and Cash, Credit / Debit Card or Cheque

A receipt will be provided on payment.

Standing Order Payment

Full Tennis and Family Tennis Renewals can be paid in three roughly equal instalments on consecutive months

The 1st payment MUST be made directly at the Club. The 2nd & 3rd payments MUST be by Standing Order

Advantage Card

Points will not be accrued on Membership Renewals.

Cards will be automatically deactivated on your renewal date if your Membership is not renewed.

Cards will be re-activated on receipt of payment, or in the case of payment by Standing Order, when the first payment has been made.

Where a first payment is made, If the second & third payments are not made on time, the Advantage Card will be deactivated.

Annual general Meeting

The AGM date has been set for Thursday 17th May 2018 at 7:30pm.

In accordance with the constitution, any resolutions to be moved at the AGM must be submitted in writing to the Secretary 28 days in advance that is, by 19th April 2018.

Election of the Management Committee and other positions

This year, as determined by our constitution, there will be elections to positions on the Management Committee.

A Nomination Board will be displayed in the bar from 19th April 2018.

Nominations must be made on the Nomination Board eight days preceding the AGM in order that in the event of multiple nominations, an election may take place over the final seven days prior to the AGM.

Nominations in any other way will be invalid and the consent of the nominee must be obtained in all cases.

A Nominee applying for election to the Management Committee must be a Full Member of the Club and have been a member of the Club for at least one year.
